Reporting to the Chair and Board, the CEO will lead the organisation to deliver its vision, build financial sustainability, strengthen governance, and enhance the reputation and reach of badminton across Scotland.

#### **Key Responsibilities**

#### 1. Strategic Leadership

Lead the development and delivery of Badminton Scotland's strategy, in partnership with the Board and key stakeholders.

Champion a clear vision and strategic plan that strengthens the sport from grassroots to elite performance.

Oversee and implement a robust financial recovery and sustainability plan.

#### 2. Commercial and Financial Management

Drive commercial growth through innovative membership, partnership, sponsorship and other funding strategies.

Ensure effective budget planning, financial oversight and resource management.

Build a financially resilient organisation capable of long-term impact.

#### 3. Stakeholder Engagement and Advocacy

Build trust and strong relationships with key partners, including sportscotland, clubs, local authorities, commercial sponsors and international bodies.

Be a visible and credible advocate for badminton. representing the sport nationally and internationally.
