- 1. The Tournament will be conducted according to the tournament regulations of BADMINTONscotland, including the prohibition of doping for which tests may be carried out.
- 2. Players must hold an active membership with BadmintonScotland in order to enter.
- A separate entry must be submitted by each competitor. No pair shall be accepted for a doubles
 event unless entries have been received from both players. Players indicating "partner required"
 will be paired wherever possible. Where there is no available partner, entry fees will be refunded.
- 4. Entries, to arrive no later than Sat 6th Sept 2025, must be sent to:

- Entries sent without the appropriate entry fees will not be accepted.
 Late entries may only be accepted at discretion of Tournament Organiser.
 Unfortunately refunds cannot be issued for withdrawals after the entry closing date.
- 6. The tournament committee reserve the right, if necessary, to:
 - Refuse to accept an entry without giving their reasons for doing so
 - Limit the number of entries in events (max 24). If required to limit entries in any event, this will be done on a first come first served basis
- 7. Any unannounced withdrawals will be notified to BadmintonScotland and monitored by the Events Committee.
- 8. Main Draw Matches will be best of 3 games to 21 points with setting. Where Qualifying Pools are used, pool matches may use different scoring system depending on entry numbers. The Referee reserves the right to amend the scoring format in any event if necessary due to time constraints.
- 9. Play will be continuous from 9:15am on Sat 20th Sept commencing with MS/WS and XD events. MD/WD events will be played in afternoon (est start 1-2pm) following completion of Singles & Mixed events. Play is estimated to finish around 7pm.
- 10. An email will be sent to all competitors 2-3 days prior to the event confirming 1st tie timings. The full draw/schedule will also be published on Tournament SW.
- **11.** Players should expect a minimum of 2 matches in Singles and 3 matches in Doubles/Mixed events. Depending on entry numbers, qualifying pools format may be used.
- **12.** No Coaching permitted. Intervals of 60s during each game when leading score reaches 11 points, and 120s between games shall be allowed in all matches.
- 13. Players shall report/check-in at the Organisers Table on arrival.

 Players should be in attendance and ready to play at least 15mins prior to first scheduled match.

 Players absent when called on to play may be scratched.
- 14. The Organisers reserve the right to add to or alter these conditions. Their decision in all matters will be final.
